Certificate Owner(s) acknowledge that an Interment Service Fee must be paid at the time of an interment.

Certificate Owner(s) agree to use the above described Rights of Interment for the sole purpose of the interment of human remains [or cremated human remains], and for no other use, intent or purpose whatsoever, subject to the Rules and Regulations of Cemetery, as they currently exist and as they may be subsequently amended, as well as any ordinances of the municipality or the State of Illinois applicable to cemeteries. In particular the Interment Rights are subject to those Rules and Regulations that pertain to the type of memorialization that can be used, the types of flowers or plantings that can be used, and Cemetery's requirements concerning outer burial containers. All such Rules and Regulations shall be binding upon the Certificate Owner(s) as well as their heirs, legal representatives, successors and assigns.

The above Rights of Interment may be sold, transferred or assigned only to other individuals for personal use, and only with the written consent of Cemetery. Such consent may be obtained by presenting this Certificate to Cemetery and paying a transfer fee. Cemetery will then cancel this Certificate and issue a new Certificate.

Certificate Owner(s) expressly acknowledge that nothing in this Certificate shall be deemed or interpreted to restrict the right of Cemetery to continue to have the full and absolute right to operate Cemetery, in its sole and absolute discretion, and without limitation to determine all physical aspects of Cemetery, including all roads, features and improvements, and to grade and improve Cemetery and all lots and spaces, and to place, replace or remove any trees, shrubbery or structures thereon.

In accordance with the laws of the State of Illinois, and the Certificate Owner's contract for purchase, Cemetery warrants that it has deposited with its Care Fund the sum of _____ (\$ _____). This deposit, along with other similar funds, shall be invested in accordance with Illinois law, and the net income from such amounts, to the extent available, shall be used for the care and maintenance of Cemetery, including administrative and overhead costs. Such moneys shall be allocated in Cemetery's sole discretion, in accordance with Illinois law.
